# Home and Community Based Services and Supports:

FSN will advocate for Home and Community Based Services and other services to bring WV into compliance with the Americans with Disabilities Act (ADA).

FSN <u>will not</u> support the development of segregated/congregate service settings.

#### **Independent Living Services:**

FSN will Advocate to expand the network of Centers for Independent Living (CILs) statewide to ensure every West Virginian with a disability has access to the services and resources provided by a CIL.

#### Housing:

Advocate for housing legislation that increases the statewide availability of accessible, economical, integrated, and safe community-based housing. We will support any legislation that supports universal design in home construction.

### **Phasing out Sub-Minimum Wage:**

FSN will advocate for the phasing out of subminimum wages for people with disabilities. Support policies, initiatives, and services that lead to more integrated and competitive employment.

#### **Improve Accessibility to Healthcare:**

FSN will advocate to help improving accessibility to healthcare/caregivers/care in rural areas of our state.
