As a Community Resource Advocate for Mt. State Center for Independent Living for more than eight years, she enjoys being a member of a community that helps people to become independent.

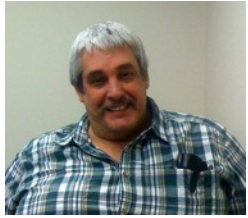

back into the community. Bob was married for 5 years; he has now lived on his own in his home since 1992.

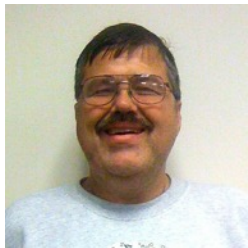
Bob was a 4-H leader for ten years. He has run for county office two times and was on the Webster County Republican Executive Committee for over 10 years.

Donald is a Member of Mountain State Centers for Independent Living Centers, Fairshake Network, WV Statewide Independent Living Council,, and Chair of CAAC.

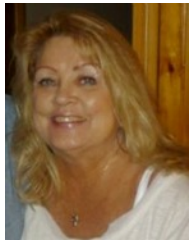
Donald would like to see that all people with disabilities be treated like everyone else.

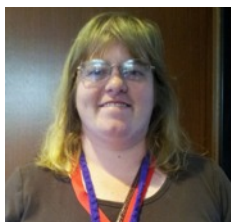
**Jeannie Elkins, at large**

**Tiffany Farley, at large**

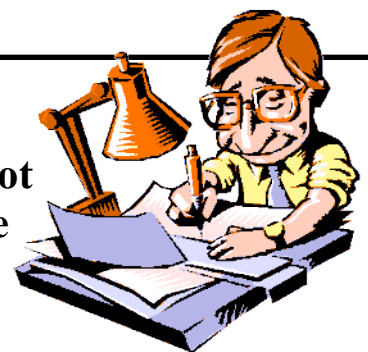

## EMPLOYMENT FIRST WORKSHOP

The Fair Shake Network, with sponsorship from the WV ADA Coalition, WV Advocates, the WV Developmental Disabilities Council, the WV Division of Rehabilitation Services and the WVU Center for Excellence in Disabilities, hosted an Employment First Workshop at the Bridgeport Conference Center on August 18, 2012.

Employment First is the concept that employment for a person with a disability should be top priority. Once a person obtains employment, other life needs become easier to obtain. This is a big part of the WVDDC's five year plan.

Speakers for the event included LuAnn Summers, Rehabilitation Program Manager for Community Rehab Programs, WVDRS, gave an overview of West Virginia Division of Rehabilitation Services; David Stewart, WV ADA Coalition Coordinator did an overview of Employees' Rights Under the ADA; Todd Rundle, Program Manager for Family Services, spoke about Assistive Technology in the workplace; Russell Sickles, Director of Operations and Business, Job Squad presented Employment First concepts; Jim Cremeans, Planner, WVDDC spoke about WV Developmental Disabilities Council's Employment First initiative; and Jennifer Tenney, Program Manager, Employment Programs, WVUCED talked about Employment Work Incentives.

It was a great workshop with a lot of wonderful information. For those who missed it, there are plans to present this workshop again sometime in 2013.

The Fair Shake Network would like to thank all of the sponsors for the great collaboration, the speakers for their time and information, and the Bridgeport Conference Center and Wingate Hotel for their hospitality.

The WV Developmental Disabilities Council is planning a PASSING workshop for the week of January 27 – February 1, 2013 (yes, that's Sunday through Friday). As someone who has attended one of our workshops on Social Role Valorization you are eligible to attend PASSING - the second half of the training. This is a practicum experience which allows you to visit two different types of programs and learn to use the PASSING instrument, which is a tool for analyzing service quality using social role valorization criteria.

You may have already attended a PASSING workshop. That doesn't preclude your attendance at this one. Some people attend both SRV and PASSING numerous times in order to develop a deeper understanding of the theory. The only details I have to share at this time are the dates and the general location, which will be Charleston, WV.

We hope that many of you will be able to take advantage of this opportunity! The WV DD Council will typically only offer this workshop biennially, so the next opportunity to attend this close to home may not be until 2015!

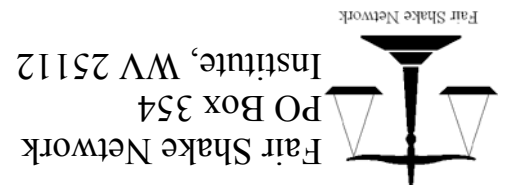
